After formal notice, any invoices which remain unpaid at the due date shall be rightfully increased by a late payment interest rate calculated on the basis of the ECB rate in force on the due date of the invoice, plus 10 points. If the invoice has not been settled before the deadline, the Organiser reserves the right to cancel the services ordered and sell them again. The amounts already paid by the Client will not be refunded. (2) VIP areas - The customisation of an area located in the VIP Village or the VIP Restaurant must be validated by the Organiser. The Organiser is free to place the tables in the VIP Restaurant as it sees fit. To facilitate access to your table, please inform us of the presence of people with reduced mobility.
